Tim Dwyer is Professor of Communication at Charles Sturt University in the School of Information and Communication Studies, and an Honorary Associate of the Discipline of Media and Communications at the University of Sydney.

Prof. Dwyer is internationally known for his media policy expertise, particularly in relation to media industries, media pluralism and public interest journalism.

His books have been adopted for a variety of media industry/studies courses in Australia, Europe and North America including at University of London, University of Southern California, University of Technology Sydney, Macquarie University, Western Sydney University, and the University of Sydney.

He has published over 100 articles, books and book chapters including peer reviewed journal articles and for other wider audience publications such as *The Conversation* and written a column since 2007 for the *Global Media Journal, Australia*. He is the recipient of five Australian Research Council funded grants, including a Linkage project and four Discovery projects, in addition to other funded research projects. He is a Chief Investigator on the Valuing News ARC DP project (2023-2026).
