Invitation to make submissions about provisional transparency notice

I am writing to invite you to make submissions regarding a provisional transparency notice (the notice) that I have issued under subsection 14B(1) of the *Foreign Influence Transparency Scheme Act 2018* (the Act).

The notice states that the Confucius Institute (the Institute) at the University of Sydney is a foreign government related entity. A copy of the notice is **enclosed**.

For the purposes of the Act, the relevant foreign principal is the Chinese International Education Foundation (as the successor entity to Hanban), and the relevant foreign jurisdiction is the People's Republic of China.

Invitation to make submissions

I invite you to make submissions to me about the provisional transparency notice within 14 days of the date of this invitation. Submissions may be sent by email to transparency@ag.gov.au or by Registered Post to:

If the notice is not revoked before the end of the period of 28 days after the date of this invitation, the notice will become a final transparency notice.

If at any time I cease to be satisfied that the Institute is a foreign government related entity, I must revoke the transparency notice.

Offences relating to false or misleading information or documents

In accordance with paragraph 14C(2)(b) of the Act, I note that the *Criminal Code* contains the following offences relating to false or misleading information or documents:

- knowingly providing false or misleading information:
 - to a Commonwealth entity
 - to a person exercising powers or performing functions under, or in connection with, a Commonwealth law, or
 - in compliance or purported compliance with a Commonwealth law,

is a serious offence under section 137.1 of the Criminal Code, and

• knowingly providing false or misleading documents in compliance or purported compliance with a Commonwealth law is a serious offence under section 137.2 of the *Criminal Code*.

The maximum penalty for each of these offences is imprisonment for 12 months.

Review of decision to issue provisional transparency notice

You may make an application to the Administrative Appeals Tribunal for review of the decision to issue a provisional transparency notice (see section 14H of the Act and the *Administrative Appeals Tribunal Act 1975*).

- Note 3: Under section 14C of the Act, the Secretary must prepare and take reasonable steps to give an invitation to the person who is the subject of this notice to make submissions to the Secretary about this notice. If this notice is not revoked before the end of the period of 28 days after the date of the invitation, this notice becomes a final transparency notice at the end of that period.
