## Clinical Ethics Discussion Group (SESLHD staff)

Ever wondered about ethical issues in your clinical work or how other staff navigate disagreement or ambiguity about the best course of action?

Discussion Group is an informal space for staff to talk about values-based questions and topics. It is not a seminar.

Any staff member can attend - no clinical ethics/bioethics skills required.

Held monthly online, it is a regular safe lunchtime meeting space for SESLHD staff to share questions and ideas and to join in conversations about cases and topics relevant to their professional work.

## Ethics CPD requirements

Health practitioner registration now includes professionalism and ethical practice as mandatory requirements in continuing professional development (CPD).

This means participants need to embed ethics and professional behaviour in annual CPD activities. (For example, the [RACP](#) requires that two CPD activities incorporate ethics and professionalism annually.)

The SESLHD Clinical Ethics Service can support clinicians with these activities, including:

- Category 1 educational activities: participate in our Discussion Group, Roundtable, Forum or other regular activities; or, complete the [Clinical Ethics eLearning](#) modules.
- Category 2 reviewing performance activities: invite us to your MDT if there are ethical issues about a complex case or bring us in as an ethics voice to your peer review process.

## Clinical Ethics Roundtable

The Clinical Ethics Roundtable sessions create some more room for ethics reflection and skill development. Roundtable is an informal and collegiate space to explore practical clinical ethics issues in greater depth and in conversation with clinicians, academics, and others. There will be speakers to introduce some cases or topics, but the aim of Roundtable is to provide an opportunity for discussions and reflection among attendees. SESLHD alternates hosting of the Roundtable with the clinical ethics teams at the Sydney Children's Hospital Network and Western Sydney LHD. There will be three Roundtable sessions in 2026.
