



Second Year Award for Electrical and Software Engineering

Terms and Conditions

1. Background

- a. The Second Year Award for Electrical and Software Engineering is to the student from the School of Electrical and Computer Engineering with the highest average mark in the second-year core units of study in conjunction with the WAM.
- b. This award is funded by School of Electrical and Computer Engineering.

2. Eligibility Criteria

- a. Students must have been enrolled in the second year of one of the below degrees at the University of Sydney in the relevant calendar year.
 - I. Bachelor of Engineering Honours (Electrical)
 - II. Bachelor of Engineering Honours (Electrical) and Bachelor of Arts
 - III. Bachelor of Engineering Honours (Electrical) and Bachelor of Commerce
 - IV. Bachelor of Engineering Honours (Electrical) and Bachelor of Design in Architecture
 - V. Bachelor of Engineering Honours (Electrical) and Bachelor of Laws
 - VI. Bachelor of Engineering Honours (Electrical) and Bachelor of Project Management
 - VII. Bachelor of Engineering Honours (Electrical) and Bachelor of Science
 - VIII. Bachelor of Engineering Honours (Software)
 - IX. Bachelor of Engineering Honours (Software) and Bachelor of Arts
 - X. Bachelor of Engineering Honours (Software) and Bachelor of Commerce
 - XI. Bachelor of Engineering Honours (Software) and Bachelor of Design in Architecture
 - XII. Bachelor of Engineering Honours (Software) and Bachelor of Laws
 - XIII. Bachelor of Engineering Honours (Software) and Bachelor of Project Management
 - XIV. Bachelor of Engineering Honours (Software) and Bachelor of Science

3. Selection Criteria

- a. The award will be presented to the student who achieves the highest average mark across second-year core units of study. If multiple students attain similar average marks in their core units, the Head of School will determine the recipient based on their Weighted Average Mark (WAM).

4. Value

- a. This award has a value of \$500 and will be paid as a one off payment.
- b. If more than one student is of equal merit, the value of the award will be equally shared by the recipients.
- c. No other amount is payable.

- d. The award will be awarded subject to the availability of funds.

5. Termination

- a. The University reserves the right to withdraw the award, if the University determines that the student is guilty of serious misconduct, including, but not limited to, having provided false or misleading information that has a relationship to the awarding of this award.
- b. Once withdrawn the award will not be reinstated unless due to University error.
