### ATTENDANCE PATTERN

A master's degree comprises 48 credit points and 24 credit points for a graduate diploma. Units of study are weighted 6 credit points unless specified otherwise. *Part-time* students may enrol in up to 12 credit points per semester. *Full-time* students must enrol in at least 18cp but no more than 24 credit points per semester (student visa holders must enrol in 24 credit points per semester). A student is expected to enrol in units of study with a total value of no more than 24 credit points per semester. A student should seek advice from the Associate Dean (E: [law.postgraduate@sydney.edu.au](mailto:law.postgraduate@sydney.edu.au)) before enrolling in more than 24 credit points per semester.

### ATTENDANCE REQUIREMENTS

All timetabled classes, activities and supervised assessments such as tests and exams are held on campus. Access to classes and reading materials are available to students who are formally enrolled in the unit. To satisfy the pass requirements for each unit of study, students are required to attend at least 70% of classes (Sessions S1C and S2C) and 100% for classes delivered in an intensive format. Students with an unsatisfactory attendance record may be refused permission to undertake assessment tasks. If you miss a class due to extenuating circumstances beyond your control (the misreading of the timetable or timetable clashes are not acceptable reasons), please notify your [Unit Coordinator](#) (or the [Education Support Team](#)) by email in a timely manner or as soon as practicable. If you do not expect to meet the class attendance requirement or available to complete all assessment tasks, please [discontinue the unit of study](#) before the start of classes or no later than the census date to avoid incurring a full fee liability and academic penalty.

##### Misreading the Timetable

##### Class Timetable Clashes

Students must select classes which do not conflict with other classes. If you have a timetable clash, please enrol in an alternative unit.

If you do not attend classes, you may fail the class attendance requirement leading to receiving an ["Absent Fail" \(AF\)](#) grade and incurring a full liability if you do not [withdraw by the census date](#). Refer to "Attendance Requirement".

#### Publication of Grades

Grades of all postgraduate law units of study, including early intensive units, are published in Sydney Student at the end of the semester around mid-July (Semester 1) and mid-December (Semester 2). Visit [Guides to grades](#).

Assessments of the [late intensive units](#) may take place later in the semester. The grades may be released after the university published date. Unit coordinators will communicate the expected grade release date with the class via Canvas announcements.

The final assessments of intensive units are generally due within 4 to 6 weeks from the last date of class. Please factor in the late assessment submission dates and marking period when planning your studies, graduation, student visas and personal/work commitments. It may be necessary to enrol in earlier intensive units. The actual assessment due dates will be published in your [unit outline](#) (available about 2 weeks prior to the first class).

#### LAST DAY TO WITHDRAW FROM A UNIT OF STUDY

100% tuition fee liability or FEE-HELP debt will incur after the relevant [withdrawal census date](#). No refund is payable for withdrawal requests received subsequent to the census date. Sydney Law School requests students intending to withdraw from an intensive unit of study to do so no later than the close of business on the first day of classes.

## CLASS SIZE-RESTRICTED AND CAPPED UNITS

In the case where class size is restricted or enrolments in a particular unit is capped due to high demand, please submit a **Departmental Permission (DP)** request to [Faculty Services](#) in [Sydney Student](#) (select 'My studies', then 'Units of study'). Please do not request permission from the unit coordinator. Students will be notified of the outcome at their university email address. Priority will be given to eligible students who are enrolled in a Sydney Law School master's degree or graduate diploma on a first come first served basis. It is strongly recommended that students finalise their enrolment in units of study as soon as possible to avoid disappointment.

## ENROLMENT IN NON-SPECIFIED UNITS

Students enrolled in the Master of Laws and Graduate Diploma in Law may choose most units of study offered within the Sydney Law School postgraduate program (unless specified otherwise). In special cases, students enrolled in a law specialist course may apply for permission to enrol in a unit of study offered within another Sydney Law School master's degree (up to 12 credit points for a master's degree and 6 credit points for a graduate diploma). ## TAXATION LAW UNITS

It is assumed that students undertaking specified tax units have an understanding of Australian income taxation law commensurate with that, which would be obtained from completing undergraduate study in Australian taxation law or five years working with Australian taxation law in a law or accounting practice, in an industry role, or in the Australian Taxation Office. Students who do not have such knowledge or work experience should undertake *LAWS6825 Introduction to Australian Business Taxation* before enrolling in other units.
