COURSE REQUIREMENTS

A master's degree requires the completion of 48 credit points, while a graduate diploma requires 24 credit points. Unless otherwise specified, each unit of study is worth 6 credit points. Part-time students may enrol in up to 12 credit points per semester. Full-time students must enrol in at least 18 credit points and no more than 24 credit points per semester. Student visa holders are required to enrol in 24 credit points per semester. The award requirements for individual courses are published in the [University of Sydney Law School Handbook](#).

LEGAL REASONING AND THE COMMON LAW SYSTEM (LAWS6252)

The unit equips students with the foundational skills and knowledge of Australian law and the legal system needed to succeed in postgraduate law studies. All *international students*, as well as those enrolled in the *MALP*, *MBL*, *MEL*, *MHL*, and *MLLR programs* (incl graduate diplomas), must enrol in this unit at the beginning of their course. LAWS6252 remains a requirement unless you have completed a full Australian law degree (or an equivalent common law degree e.g. UK or Canada etc).

ATTENDANCE REQUIREMENTS

All classes, learning activities, and supervised assessments are held in person on campus and are only accessible to students formally enrolled in the unit. Students must attend at least 70% of classes, as specified in the [unit outline](#), to avoid receiving an "Absent Fail" (AF) grade. For intensive units of study, students are expected to attend all scheduled sessions. If you believe you cannot meet the requirements, it is strongly recommended that you discontinue the unit by the [census date](#). Enrolment in Intensive Units

Students must not attempt to enrol in or attend classes for an intensive unit that has commenced. If you experience enrolment issues in [Sydney Student](#), you should submit a [Unit of study selection issue form](#) to Faculty Services well in advance of the first class.

Law School Class Timetable

Misreading the Timetable

It is each student's responsibility to note their class dates and ensure they attend classes at the scheduled times. Class dates are published in your personal [Sydney timetable](#). Careful attention to these sources will help avoid errors and missed classes.

Class Timetable Clashes

Students must select classes that do not conflict with other scheduled classes. If a timetable clash occurs, you are required to enrol in an alternative unit. Misreading the timetable or enrolling in units with timetable clashes are not acceptable reasons for class absences. Failure to attend classes will result in not meeting the class attendance requirement, which may lead to an "Absent Fail" (AF) grade and full financial liability if you do not withdraw by the [census date](#).

Publication of Grades

Grades for all postgraduate law units, including early intensive units, are published in Sydney Student at the end of each semester, around mid-July for Semester 1 and mid-December for Semester 2. For further details, please refer to the [Guides to grades](#).

Assessments for late intensive units may occur later in the semester, and grades may be released after the official university date. Unit coordinators will confirm the expected grade release date via [Canvas](#). Final assessments for intensive units are generally due within 4 weeks of the last class. Students should take these later submission dates and marking periods into account when planning their studies, graduation, student visa requirements, and personal or work commitments. In some cases, enrolling in earlier intensive units may be necessary. The actual assessment due dates will be published in the [unit outline](#), which is released approximately two weeks before the first class.

ENROLMENT IN NON-SPECIFIED UNITS

Students enrolled in the Master of Laws or Graduate Diploma in Law may select most units from the Sydney Law School

postgraduate program, unless otherwise specified. In special cases, students in specialist law courses may apply to enrol in units offered under another Sydney Law School master's degree, up to 12 credit points for a master's degree and 6 credit points for a graduate diploma. All students must complete at least 50% of the units prescribed for their specific course.
