## Indonesia Dr Liam Gammon Australian National University

Liam Gammon is a Research Fellow at the East Asian Bureau of Economic Research (EABER) at the Crawford School of Public



Policy. A specialist in contemporary Indonesian politics, he also convenes an introductory ANU undergraduate course in Asian politics. As an awardee of the 2024 Japan Foundation Indo-Pacific Partnerships Program (JFIPP) Research Fellowship, he is engaged in ongoing survey-based research into the political values of Gen-7 voters in Indonesia.

Liam is the editor of New Mandala, the ANU-based Southeast Asian studies website, and is a member of the editorial board of East Asia Forum. He received his PhD from the ANU Coral Bell School of Asia Pacific Affairs for a thesis examining the role Indonesia's electoral institutions played in moderating the impacts of populism on the post-reformasi political system.

## Malaysia Associate Professor Ross Tapsell Australian National University

Ross Tapsell is an Associate Professor at the Australian National University's College of Asia and the Pacific. He is currently Director of the ANU's Malaysia Institute, which fosters a closer



relationship between Australia and Malaysia through research and dialogue. He is the author of books and journal articles on media, culture, politics and society in Southeast Asia, predominantly Indonesia and Malaysia, and has written for The New York Times, The Guardian, VICE and other publications in the Southeast Asian region.

### Philippines Dr Sol Iglesias University of Philippines

Sol Iglesias is an assistant professor of Political Science at the University of the Philippines. She is a member of the Editorial



Advisory Board of New Mandala and co-convener of the Women in Southeast Asian Social Sciences. She was the Inaugural Scholar-in-Residence of the Justice in Southeast Asia Laboratory at the University of Wisconsin-Madison in 2023. The American Political Science Association's (APSA) Democracy and Autocracy Committee selected her as an Emerging Scholar in 2020 and she won an APSA Asia Program fellowship and research grant in 2021. She was a Southeast Asia Research Group Fellow in 2017. She has a Ph.D. in Southeast Asian Studies and an M.A. in Political Science from the National University of Singapore as well as an M.A. in International Affairs from the Fletcher School of Law and Diplomacy at Tufts University and a B.A. in Public Administration from the University of the Philippines.

# **Singapore Dr Gillian Koh**Lee Kuan Yew School of Public Policy

Gillian KOH is Senior Research Fellow at the Institute of Policy Studies (IPS), National University of Singapore.

Her research interests are in electoral politics, the development



of civil society and state-society relations in Singapore. Among other things, she conducts surveys on Singaporeans' political attitudes, sense of identity, rootedness and resilience and has also helmed several IPS scenario-planning projects. She has published and co-published articles on civil society and political development in Singapore. She was co-editor of Migration and Integration in Singapore: Policies and Practice (2015) as well as State-Society Relations in Singapore (2000) and Civil Society and the State in Singapore (2017) and co-author of Singapore Chronicles: Civil Society (2016) as well as Social Capital in Singapore. The Power of Network Diversity (2021).

She was Deputy Director (Research) at IPS from 2016 to 2023. She received her PhD in Sociological Studies from the University of Sheffield, United Kingdom in 1995 and has been at the Institute since 1996.

# Thailand Dr Ladawan Khaikham Kasetsart University

Ladawan Khaikham (PhD) is an Assistant Professor in the Department of Political Science and Public Administration at

Kasetsart University, Thailand. She holds a Ph.D. in Political Science from the Australian National University and an MSc in Political Theory from the London School of Economics. Her research focuses on environmental politics, political theory, and human rights, with a growing emphasis on Chinese governance and sustainable development. Her ongoing research projects explore democratic environmentalism in Southeast Asia and comparative public policy responses to pollution across the region. She is actively engaged in regional academic dialogues, with presentations at several conferences such as EuroSEAS and the International Conference on Democracy and Elections in Asia.

## **Vietnam Andrew Goledzinowski**Former Australian Ambassador to Vietnam

During a distinguished diplomatic career, Andrew Goledzinowski AM served as Australia's Ambassador to Vietnam, High Commissioner to Malaysia, Ambassador for People Smuggling and Human Trafficking Issues and Ambassador/Deputy PR to the United Nations. He was also posted to Geneva, Port Vila, Pretoria and Wellington and led numerous emergency deployments e.g. Ukraine, Iraq, Syria and Fiji.

In addition to his diplomatic postings, Andrew served as: Chief of Staff to the UN High Commissioner for Human Rights in Geneva, Chair of International Cooperation within the Iraqi Coalition Provisional Authority, Head of the World Bank Office in Baghdad, and Senior Adviser to two Australian Foreign Ministers. Presently, Andrew is working as an independent advisor and consultant. He is a Fellow of the Australia Vietnam Policy Institute, a Board Member of the Australia Vietnam Medical Foundation, Strategic Advisor to the Vietnam-Australia Scholars and Experts Association (VASEA) and Patron of Global Viet Women. Andrew has received numerous awards for his work, most recently being honored with a Doctorate of Laws in recognition of his contributions to international relations.
