Mr Gerard Stevens AM, founder and Managing Director of Manrex Pty Ltd-Webstercare, is an exceptional leader in the pharmacy industry.

Gerard graduated with the Bachelor of Pharmacy in 1968 and went on to found his company Webstercare. For more than 30 years, Webstercare has been an innovation-led company at the vanguard of solving the problems Australians have with managing their medication.

Webstercare has developed more than 600 products and services that each offer smart solutions to medication management concerns across a range of sectors. The now widely-used Webster-pak was an early development that became an industry standard; and newer innovations include the robotically enhanced MedsPro mini-dispensary system that utilises the Virtual Pill Count software, which supports large numbers of patients requiring medication management support.

The first pharmacist in Australia to qualify for Residential Medication Management Reviews (RMMR), Gerard has now become the leading provider of RMMR services in Australia today.

Gerard's continued passion and commitment to research, development and better patient care has enabled Webstercare to remain at the forefront of the industry. His innovations are used throughout the pharmacy, aged care, community and health sectors and his commitment has led to better health outcomes for Aboriginal and Torres Strait Islander communities.

This passion, commitment and resulting contributions were recognised in 2013 when Gerard was appointed a Member in the General Division of the Order of Australia in recognition for his "significant service to the pharmaceutical industry, and to community health".

He has also received national and international recognition for his innovation, forward thinking and commitment to the industry and patients.

In 2010 Gerard was honoured by the Pharmaceutical Society of Australia with a Lifetime Achievement Award in recognition of his dedication to promoting excellence in the pharmacy profession over a substantial period of time. In the same year he was also the recipient of the Federation of Asian Pharmaceutical Associations (FAPA) Ishidate Award for Community Pharmacy.
